CONSULTANCY SERVICES FOR PREPARATION OF TRAFFIC AND TRANSPORTATION MASTER PLAN FOR SILIGURI JALPAIGURI PLANNING AREA

The Siliguri Jalpaiguri Planning Area (SJPA) is an important urban agglomeration in the north of West Bengal, situated at a strategic location and acting as a gateway to the North-Eastern states of India. It serves as the distribution and collection centre for the entire region, which is rich in natural and human resources. With rapid urbanization the region is experiencing traffic and transportation problems, and needs sustainable solutions to overcome these issues.

SJDA now proposes to prepare a Traffic and Transportation Master Plan for Siliguri Jalpaiguri Planning Area to develop a long term transport strategy with suitably interlaced medium and short term development plans for region in this sector.

SJDA invites Expression of Interest (Eoi) from interested firms of consultants for providing the Consultancy Services to prepare a Traffic and Transportation Master Plan as mentioned above.

The consultants / consulting firms shall be a single entity with the following eligibility criteria:

- i. Must have prepared Transportation/Development Plan for cities of comparable size of not less than 1 million population in the last Five Years;
- ii. Demonstrated Experience in planning and designing of at least one high capacity Public Transport System (MRTS/LRTS/BRTS etc.) in cities of similar nature and size in the last Five Years.

The EOI submission should include a) Firm's Credential including certificate of incorporation, profile, general and relevant experiences, organization structure with staffing, b) List of Projects handled in last five years including project description sheets & certificates from client of relevant projects, c) Human Resources with CVs of potential professionals from various disciplines who can work on this assignment d) Other information as deemed appropriate by the consultants.
