NOTICE INVITING TENDER

Sealed tenders are invited on behalf of **Siliguri Jalpaiguri Development Authority** from resourceful, bonafide and experienced agencies of the following work:

1. **Name of work:** Lighting arrangement at Shew Mangal Memorial Hindi High School field, Bankim Nagar, Siliguri
2. **Name of Tendering Authority:** Chief Executive Officer, Siliguri Jalpaiguri Development Authority.
3. **Amount put to Tender:** Rs.4, 60, 115.00
4. **Time of completion:** 21 (twenty one) Days.
5. **Issue of Tender Documents / Papers:**

- a) Intending tenderers may obtain the Tender Documents / Papers from the Cash Section of Siliguri Jalpaiguri Development Authority only on payment of requisite amount of Demand Draft / Pay Order or Challan to be deposited in **United Bank of India** in favour of Chief Executive Officer, Siliguri Jalpaiguri Development Authority. No tender paper will be sold beyond the last date of purchasing tender.
- b) **Last date & time of Purchasing Tender Form: 08.05.2015 up to 5.00 PM.**

6. **Submission of Tenders:**

Mode of submission: The tenderers shall submit their tenders in two sealed covers enclosed in a main sealed envelope addressed to the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Tenzing Norgey Road, Pradhan Nagar, Siliguri – 734 003.

The sealed cover no. 1 shall be superscribed as “**Part – I (Technical Bid)**” containing technical and financial specifications / particulars as detailed under 6(a) and 6(b) below along with the Earnest Money and cost of tender documents (if necessary).

The sealed cover no. 2 shall be superscribed as “**Part – II (Financial Bid)**” containing rate duly filled up, in the tender documents purchased or down loaded, in percentage terms At – Par, Below or Above than the Departmental Price Schedule attached for the work.

- a) **Documents to be submitted:** Self attested Copies of the following documents will be submitted by the quotationer /(s) for pre-qualification. Failure of submission of any of the documents as listed below will render the Tender/Quotation liable to be summarily rejected.
 - i) **Trade License.**
 - ii) **Electrical contractors license with validity period.**
 - iii) **Partnership Firm / Co-Operative Society Profile** with all relevant papers of its establishment.
 - iv) **Income Tax (I.T.) PAN.**
 - v) **P. Tax** registration certificate with updated documents.
 - vi) **VAT Registration Certificate** (If registered).
 - vii) **Electrical supervisors’ certificate** of competency in parts 6(a), 7(a) or equivalent **National Supervisors Certificate** of competency.
 - viii) **Credential** of similar nature of Street lighting works amounting to Rs.1.85 Lac executed by the Agency during last 5 years along with **Work Order and Completion Certificate / Payment Certificate.**
 - ix) A written declaration in the form of **Affidavit before Notary** as the correctness of the copies of all documents mentioning the NIT no. and name of the work.
- b) **Financial Instruments:**
 - a. **Earnest Money: Rs. 9210.00** (May be paid in the form of Demand Draft / Pay Order in favour of Chief Executive Officer, Siliguri Jalpaiguri Development Authority) should be attached along with **Part – I, i.e. Technical Part.**
 - b. **Cost of Tender Form: Rs. 700.00** (May be paid in the form of Demand Draft / Pay Order or Challan to be deposited in **United Bank of India** in favour of Chief Executive Officer, Siliguri Jalpaiguri Development Authority).
 - c) **Last date & time of Submission: 12.05.2015 up to 1.30 PM.**
7. **Receiving of Tender Documents / Papers:** Tender will be received through tender box kept in the office of the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Siliguri.

8. **Opening of Tenders:** "Part – I" will be opened on **12.05.2015 at 2.30 PM** and the "Part – II" of the qualified tenderers will be opened on **12.05.2015 at 4.00 PM**. The tenderers or their authorized representatives may like to present at the time of opening of both "Part – I" and "Part – II". The schedule of opening may be altered depending on unavoidable circumstances.
9. The tenderers shall have to show original copies of the submitted documents at the time of evaluation of the tenders.
10. **Details of Work:** The details of the work may be seen in the tender documents / papers or from the tendering wing of the Engineering Section.
11. The tendering authority is not bound to accept the lowest rates and reserves the right to cancel any or the entire tender / (s) without assigning any reason there to.
12. The rate quoted in the proper place of the tender form enclosed with the tender documents shall only be treated as valid and no other conditions along with or submitted later on shall be acceptable.
13. 1 % Cess will be deducted from the Bill (s) for welfare of labour as per Govt. notification.
14. If the lowest rate comes to below 10 % of the estimated value then performance security @ 2.5% of the contract value should be paid in the form of Demand Draft in favour of CEO, SJDA before the process of Formal Tender, failing which action will be taken and the order will be treated as cancelled. The same may be released after completion of the work with value of at least 80%
15. The maintenance period of the work including all its components to be of **3(three) years** from the date of completion. The refund of Security Deposit would be in the following manner subject to quality and proper maintenance of the work and its components satisfactory for the entire period of **3(three) years**.
 - (i) 30% of the Security Deposit shall be refunded on expiry of 1(One) year from the date of completion.
 - (ii) 30% of the Security Deposit shall be refunded on expiry of 2(Two) years from the date of completion.
 - (iii) 40% of the Security Deposit shall be refunded on expiry of 3(Three) year from the date of completion.
16. The lowest quotationer will have to enter into an agreement in SJDA's format within **7 (Seven) working Days** else the same will be treated as cancelled.
17. All works shall be executed in adherence to the Electricity Act, 2003.
