Sealed quotations are invited in two bid system on behalf of Siliguri Jalpaiguri Development Authority from resourceful, bonafide and experienced firms / consultants for "Preparation of Detailed Project Report (DPR) & Project Management Consultancy work for the Heritage Conservation & Protection of two nos. Heritage Shiv Mandir's allied works within the Compound of Jalpaiguri Rajbari Dighi under SJDA".

Scope of work:

[A] Preparation of Detail Project Report (DPR) as follows:

- 1) Preparation of preliminary Concept Plan, Elevation including Architectural detailing.
- 2) Submission of Final Concept Plan and Architectural Drawings (incorporating required changes if any, as suggested by the Authority).
- 3) After getting NOC, submission of vetted Structural and Electrical Designs and Drawings including estimates based on latest PWD schedule of Rates and Market analysis, BOQ for Tender process. (vetting to be done from IIT/ IIS/JU/ any Govt. Engineering College)
- 4) Evaluation of the Tender and preparation of Comparative Statement.
- 5) Submission of complete set of Layout and full scale Working Drawings for all types of works including Line Diagrams for Electrical and other works as required.
- 6) Day to day supervision of the work including review of quality as and when required till completion of the Project. (Quality tests to be arranged and completed by the Contractor).
- 7) Record entries to be done by the concern Engineer of the Authority in presence and consent of the Consultant appointed Engineer/ Architect.


