Sealed tenders are invited on behalf of **Siliguri Jalpaiguri Development Authority** from resourceful, bonafide and experienced agencies of the following work:

1. **Name of work:** Construction of 10 Nos. 1200 MM wide Culverts at LIG, MIG & HIG Blocks for Drainage Scheme at Composite Complex, Jalpaiguri.
2. **Name of Tendering Authority:** Chief Executive Officer, Siliguri Jalpaiguri Development Authority.
3. **Amount put to Tender:** Rs. 13, 43, 577.00
4. **Time of completion:** 3 (Three) Months.
5. **Issue of Tender Documents / Papers:**

a) Intending tenderers may obtain the Tender Documents / Papers from the Cash Section of Siliguri Jalpaiguri Development Authority only on payment of requisite amount of Demand Draft / Pay Order. No tender paper will be sold beyond the last date of purchasing tender.

b) **Last date & time of Purchasing Tender Form:** 21.01.2013 up to 5.00 PM.

6. **Submission of Tenders:**

a) **Mode of submission:** The tenderers shall submit their tenders in two sealed covers enclosed in a main sealed envelope addressed to the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Tenzing Norgey Road, Pradhan Nagar, Siliguri – 734 003.

The sealed cover no. 1 shall be superscribed as “**Part – I (Technical Bid)**” containing technical and financial specifications / particulars as detailed under 6 (b) and 6 (c) below along with the Earnest Money and cost of tender documents (if necessary).

The sealed cover no. 2 shall be superscribed as “**Part – II (Financial Bid)**” containing rate duly filled up, in the tender documents purchased or down loaded, in percentage terms At – Par, Below or Above than the Departmental Price Schedule attached for the work.

b) **Documents to be submitted:** A list of Self Attested photocopies with serial number of pages of the following documents will be submitted by the Contractor / (s) in the financial part (sl. no. i to v) and Technical Part (sl. no. vi to vii) for pre-qualification.


- i) Income Tax (I.T.) PAN along with the copy of latest Return submitted to I.T. Authority.
- ii) Professional Tax (P.T.) Registration Certificate along with updated documents.
- iii) Value Added Tax (VAT) Registration Certificate along with updated documents (If registered).
- iv) In case of Co-operative Societies, Registration Certificate that covered under Co – operative Act to be provided with application.
- v) Payment Certificates / Audited Balance Sheet (any one) in any year during last three years may be submitted in support of turnover for the value of Rs. 13.44 lac.
- vi) Work Order, Completion Certificate & Payment Certificate of project / job under any Government / Semi Government / Undertakings / Autonomous / Statutory bodies and Local bodies, with requisite single tender within the last five years value of Rs. 6.72 lac.
- vii) List of machineries as Hopper type Mixture Machine, Vibrator etc. and construction equipments related to the same nature of work owned / arranged by the agency with proper valid documents along with an undertaking should be submitted.
- viii) The tenderers shall have to show original copies of the submitted documents at the time of evaluation of the tenders.
- ix) Tenderer or his authorised representative must be present at the time of opening of “**Part – I (Technical Bid)**” & “**Part – II (Financial Bid)**”.

c) **Financial Instruments:**

- i) **Earnest Money:** Rs. 26, 872.00 (May be paid in the form of Demand Draft / Pay Order in favour of Chief Executive Officer, Siliguri Jalpaiguri Development Authority) should be attached along with Part – I i.e., Technical Part.
- ii) **Cost of Tender Form:** Rs. 1, 000.00 (May be paid in the form of Demand Draft / Pay Order or Challan to be deposited in **United Bank of India** in favour of Chief Executive Officer, Siliguri Jalpaiguri Development Authority).

d) Last date & time of Submission: 28.01.2013 up to 2.30 PM.

7. **Receiving of Tender Documents / Papers:** Tender will be receive through tender box kept in the office of the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Siliguri.
8. **Opening of Tenders:** "Part – I" will be opened on 28.01.2013 at 3.00 PM and the "Part – II" of the qualified tenderers will be opened on 28.01.2013 at 5.00 PM. The tenderers or their authorized representatives may like to present at the time of opening of both "Part – I" and "Part – II". The schedule of opening may be altered depending on unavoidable circumstances.
9. **Details of Work:** The details of the work may be seen in the tender documents / papers or from the tendering wing of the Engineering Section.
10. **Departmental Materials:** The recovery rates for departmental materials are as follows:  
Cement: Rs. 7,050.00 / MT Steel: Rs. 56, 880.00 / MT.
11. The tendering authority is not bound to accept the lowest rates and reserves the right to cancel any or the entire tender / (s) without assigning any reason there to.
12. The rate quoted in the proper place of the tender form enclosed with the tender documents shall only be treated as valid and no other conditions along with or submitted later on shall be acceptable.
13. 1 % Cess will be deducted from the Bill (s) for welfare of labour as per Govt. notification.
14. If the lowest rate comes to below 10 % of the estimated value then performance security @ 2.5% of the contract value should be paid in the form of Demand Draft in favour of CEO, SJDA before the process of Formal Tender, failing which action will be taken and the order will be treated as cancelled. The same may be released after completion of the work with value of at least 80%.
15. The maintenance period of the work to be considered as 3 (Three) years from the date of completion of the work and the release of Security Deposit would be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of three years.
  1. Completion of 1<sup>st</sup> year from the date of completion – 30 % of SD
  2. Completion of 2<sup>nd</sup> year from the date of completion – 30 % of SD
  3. Completion of 3<sup>rd</sup> year from the date of completion – 40 % of SD.


