In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the tenderer.

- 12. The tenderers shall have to show original copies of the submitted documents at the time of evaluation of the tenders.
- 13. Tenderer or his authorised representative must be present at the time of opening of "Part I (Technical Bid)" & "Part II (Financial Bid)".
- 14. Details of Work: The details of the work may be seen in the tender documents / papers or from the tendering wing of the Engineering Section.
- 15. The tendering authority is not bound to accept the lowest rates and reserves the right to cancel any or the entire tender / (s) without assigning any reason there to.

The same may be released after completion of the work with value of at least 80%
