## **NOTICE INVITING TENDER**

Sealed tenders are invited on behalf of Siliguri Jalpaiguri Development Authority from resourceful, bonafide and experienced agencies of the following work:

1. **Name of work:** Construction of a Culvert at Back side of N.B.S.T.C. Road (West Side) for draining out Water from outer pits of S.J.D.A. Market Complex with some new pit cover and some inside Plumbing works of S.J.D.A. Market, Siliguri, Dist. Darjeeling.
2. **Name of Tendering Authority:** Chief Executive Officer, Siliguri Jalpaiguri Development Authority.
3. **Amount put to Tender:** Rs. 1,34,913.00
4. **Earnest Money :** Rs. 2,698.00
5. **Cost of Tender:** Rs. 700.00
6. **Time of completion:** 60 (Six Zero) Days.
7. **All materials required for the proposed scheme including cement , steel and Bitumen shall be of specified grade and approved brand in conformity with relevant code of practice (latest revision) and manufacture accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Authenticated evidence for purchase of cement and steel are to be submitted along with challan and test certificate. In the event of further testing opted by the Engineer-in-Charge, then such testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.**

8. **Issue of Tender Documents / Papers:**

9. **Submission of Tenders:**

- a) **Mode of submission:** The tenderers shall submit their tenders in two sealed covers enclosed in a main sealed envelope addressed to the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Tenzing Norgey Road, Pradhan Nagar, Siliguri – 734 003.

The sealed cover no. 1 shall be superscribed as “**Part – I (Technical Bid)**” containing technical and financial specifications / particulars as detailed under 6 (b) and 6 (c) below along with the Earnest Money and cost of tender documents (if necessary).

The sealed cover no. 2 shall be superscribed as “**Part – II (Financial Bid)**” containing rate duly filled up, in the tender documents purchased in percentage terms At – Par, Below or Above than the Departmental Price Schedule attached for the work.

**Documents to be submitted:** Self attested Copies of the following documents will be submitted by the tenderer /(s) for pre-qualification. Failure of submission of any of the documents as listed below will render the Tender/Quotation liable to be summarily rejected. in the form of Affidavit before Notary as the correctness.

- i) **Trade License.**
- ii) **Partnership Firm / Co-Operative Society Profile with all relevant papers of its establishment.**
- iii) **Income Tax (I.T.) PAN.**
- iv) **P. Tax registration certificate with updated documents.**
- v) **Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017.**
- vi) **“Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017” / In terms of 4374 F (V).**



- vii) Payment Certificate(s) for the value of Rs. 1.34 Lac completed work or any supply work within the last five financial years.
- viii) A written declaration in the form of Affidavit before Notary as the correctness of the copies of all documents mentioning the NIT no. and name of the work.
- ix) Requirement of Credential (As per G.O no- 04A/PW/O/10C-02/14, Dt-18.03.2015).

A For 3rd and onward Call of NIT: -	
i.	Intending tenderers should produce credentials of a similar nature of completed work of the minimum value of 20% of the estimated amount put to tender during 5 (Five) years prior to the date of issue of the tender notice; or,
ii.	Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 70% or more and value of which is not less than the desired value at (i) above;
In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the tenderer.	

**N.B.:** In case of 9. ix) [A i.] *Work Order, Completion Certificate with Gross Bill Value or Payment Certificate for successful completed work shall have to be submitted* but in case of 9. ix) [A ii.] the *Certificate of satisfactory running work shall have to be submitted*

#### Financial Instruments:

10. **Earnest Money:** The amount of Earnest Money Deposit (EMD) is 2% (Two percent) of the estimated amount put to tender must be submitted in the form of NEFT / RTGS of any scheduled Commercial Bank in India approved by RBI & having a branch in West Bengal which is to be drawn in favour of the **CHIEF EXECUTIVE OFFICER (CEO), SJDA**. The **acknowledgement with UTR No. should be submitted with Bid Documents**. Payment in any other forms i.e.: NSC, KVP, cheques etc. will not be accepted. The Chief Executive Officer, if required by the bank will within 7 working days after being approached in writing with the instrument of EMD by the unsuccessful bidders, release the EMD pledged in his/her favour after opening of technical and financial bids, other than L1 and L2. EMD of L2 bidder is to be released only after issuance of LOI / LOA in favour of L1 within next seven working days thereafter.  
**If such bidder(s), having participated in the 1st Call of a work which has been cancelled due to insufficient number of participants or otherwise intends to participate in the 2nd Call of the same work, they are to submit fresh EMD and no prayer for adjustment of previous EMD will be considered.**

11. **Receiving of Tender Documents / Papers:** Tender will be received through tender box kept in the office of the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Siliguri.
12. **Opening of Tenders:** "Part – I" will be opened on 04.12.2017 at 4.00 PM and the "Part – II" of the qualified tenderers will be opened on 04.12.2017 at 4.30 PM. The tenderers or their authorized representatives may like to present at the time of opening of both "Part – I" and "Part – II". The schedule of opening may be altered depending on unavoidable circumstances.
13. The tenderers shall have to show original copies of the submitted documents at the time of evaluation of the tenders.
14. Tenderer or his authorised representative must be present at the time of opening of "Part – I (Technical Bid)" & "Part – II (Financial Bid)".
15. **Details of Work:** The details of the work may be seen in the tender documents / papers or from the tendering wing of the Engineering Section.
16. The tendering authority is not bound to accept the lowest rates and reserves the right to cancel any or the entire tender / (s) without assigning any reason there to.
17. The rate quoted in the proper place of the tender form enclosed with the tender documents shall only be treated as valid and no other conditions along with or submitted later on shall be acceptable.
18. If the lowest rate comes to below 10 % of the estimated value then performance security @ 2.5% of the contract value should be paid in the form of Demand Draft in favour of CEO, SJDA before the process of Formal Tender, failing which



action will be taken and the order will be treated as cancelled. The same may be released after completion of the work with value of at least 80%.


19. The bidder shall be required to properly maintain the work including all its components for a period of 3 (Three) years from the date of completion and handing over to SJDA in proper format, a Security Deposit of 10% shall be deducted from each RA bill (up to 10% in total). 2% EMD is to be adjusted with the Security Deposit. The release of S.D. would be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of 3 (Three) years.

1. Completion of 1<sup>st</sup> year from the date of completion – 30 % of SD

2. Completion of 2<sup>nd</sup> year from the date of completion – 30 % of SD

3. Completion of 3<sup>rd</sup> year from the date of completion – 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.


