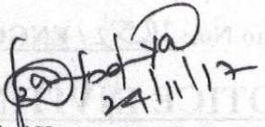

3. Completion of 3rd year from the date of completion – 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.

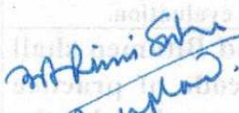
