

1. Completion of 1<sup>st</sup> year from the date of completion - 30 % of SD
2. Completion of 2<sup>nd</sup> year from the date of completion - 30 % of SD
3. Completion of 3<sup>rd</sup> year from the date of completion - 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.




