**Name of work:** Providing & installation of Water Cooler Cum Water Purifier at MC William High School, Dist. Alipurduar.

All materials required for the proposed scheme including cement , steel and Bitumen shall be of specified grade and approved brand in conformity with relevant code of practice (latest revision) and manufacture accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Authenticated evidence for purchase of cement and steel are to be submitted along with challan and test certificate. In the event of further testing opted by the Engineer-in-Charge, then such testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.

**Financial Instruments:**

9. **Earnest Money:** The amount of Earnest Money Deposit (EMD) is 2% (Two percent) of the estimated amount put to tender must be submitted in the form of NEFT / RTGS of any scheduled Commercial Bank in India approved by RBI & having a branch in West Bengal which is to be drawn in favour of the **CHIEF EXECUTIVE OFFICER (CEO), SJDA**. The **acknowledgement with UTR No. should be submitted with Bid Documents**. The Chief Executive Officer, if required by the bank will within 7 working days after being approached in writing with the instrument of EMD by the unsuccessful bidders, release the EMD pledged in his/her favour after opening of technical and financial bids, other than L1 and L2. EMD of L2 bidder is to be released only after issuance of LOF/ LOA in favour of L1 within next seven working days thereafter.

**If such bidder(s), having participated in the 1st tender of a work which has been cancelled due to insufficient number of participants or otherwise intends to participate in the 2nd Call of the same work, they are to submit fresh EMD and no prayer for adjustment of previous EMD will be considered.**

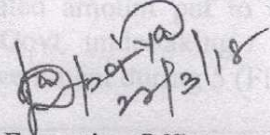

10. **Receiving of Tender Documents / Papers:** Tender will be received through tender box kept in the office of the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Siliguri.
11. **Opening of Tenders:** "Part – I" will be opened on **06.04.2018 at 3.00 PM** and the "Part – II" of the qualified tenderers will be opened on **06.04.2018 at 4.00 PM**. The tenderers or their authorized representatives may like to present at the time of opening of both "Part – I" and "Part – II". The schedule of opening may be altered depending on unavoidable circumstances.
12. The tenderers shall have to show original copies of the submitted documents at the time of evaluation of the tenders.
13. Tenderer or his authorised representative must be present at the time of opening of "**Part – I (Technical Bid)**" & "**Part – II (Financial Bid)**".
14. **Details of Work:** The details of the work may be seen in the tender documents / papers or from the tendering wing of the Engineering Section.
15. The tendering authority is not bound to accept the lowest rates and reserves the right to cancel any or the entire tender / (s) without assigning any reason there to.
16. The rate quoted in the proper place of the tender form enclosed with the tender documents shall only be treated as valid and no other conditions along with or submitted later on shall be acceptable.

The lowest rate comes to below 10 % of the estimated value then performance security @ 2.5% of the contract value should be paid in the form of Demand Draft in favour of CEO, SJDA before the process of Formal Tender, failing which action will be taken and the order will be treated as cancelled. The same may be released after completion of the work with value of at least 80%

5. The bidder shall be required to properly maintain the work including all its components for a period of **1 (One) year** from the date of completion and handing over to SJDA in proper format, a Security Deposit of 10% shall be deducted from each RA bill (up to 10% in total). 2% EMD is to be adjusted with the Security Deposit. The release of S.D. would be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of **1 (One) year**.

Failure to execute proper maintenance of the work for one year will lead to forfeiture of the security deposit.

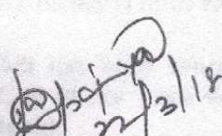
