

The release of S.D. would be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of 3 (Three) years.

1. Completion of 1<sup>st</sup> year from the date of completion – 30 % of SD
2. Completion of 3<sup>rd</sup> year from the date of completion – 30 % of SD
3. Completion of 3<sup>rd</sup> year from the date of completion – 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.


