
be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of 3 (Three) years.

1. Completion of 1st year from the date of completion – 30 % of SD
2. Completion of 2nd year from the date of completion – 30 % of SD
3. Completion of 3rd year from the date of completion – 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.

In the event of any of the above-mentioned dates being declared as a holiday for SJDA the tender will be opened on the next working day at the appointed time.


