EXPRESSION OF INTEREST FOR PLANNING, DESIGNING AND ESTIMATE AS PER ATTACHED DRAWING CONSTRUCTION OF CENTRAL HOSTEL FOR S.T. GIRLS AT PARIMAL SMRITI MAHAVIDYALAYA AT MALBAZAR DIST. JALPAIGURI UNDER BACKWARD CLASSES WELFARE, JALPAIGURI.

Sealed Expression of Interest (EOI) are invited by Siliguri Jalpaiguri Development Authority (SJDA) from the registered, bonafide, reliable and resourceful Architects / Agencies / Consultancy Firms having experience of not less than five years in Planning, Designing and preparation of DPR.

#### About the Project:

Construction of Central Hostel for S.T. Girls at Parimal Mitra Smriti Mahavidyalaya at Malbazar Dist. Jalpaiguri under Backward Classes Welfare, Jalpaiguri.

The building complex would be upto G+2 storied and design should be done accordingly.

Some changes in the plan may be done as per necessary for design purpose.

#### Scope of Work:

The work would include preparation of detail Structural Designs, change in drawing if required including preparation of detail estimate of the proposed building complex with bill of quantities including sanitary, plumbing, electrical, firefighting arrangements, other ancillaries etc. The detailed estimate is to be prepared on the basis of PWD schedules. In case of non-scheduled items, analysis of rates may also be provided. The selected Consultant would have to provide the following:

- 1) Structural Design of the Building including vetting of the Structural Design of the building.
- 2) Detail design & drawings of Water Supply, Sewerage, Drainage, Electricals, other related ancillaries.
- 3) Preparation of detailed estimate, bill of quantities for the building and ancillary works like electrical, sanitary, fire-fighting arrangements.

Registered, bonafide, reliable and resourceful Architects / Agencies / Consultancy Firms having not it than five years of experience in designing similar type of buildings may participate in this Expression of Interest (EOI). 
Technical bid shall contain.

- 1) Total Turnover of the company / firm for the last 3 years i.e. upto 31.3.2018 specifying eligibility criteria.
- 2) Partnership Deed with Registration Certificate in case of partnership firm / Trade License / Company Registration Certificate valid at least up to the date of submitting their bid.
- 3) Service Tax Registration Certificate.
- 4) Income Tax (I.T.) PAN.
- 5) Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017.
- 6) "Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017" / in terms of 4374 F (Y)
- 7) Auditor's Certificate for Turnover for the last three years, i.e., upto 31.03.2018. Any participant bidder not following the steps in submitting their bid /offer as described are liable to be disqualified.
- 8) Experience on successful preparation of similar type of works specifying eligibility criteria
- 9) Key professional staff qualification and competence for the assignment (Details of Architects and Engineers).
- 10) Concept proposal
