Intending tenderers should produce credentials of a similar nature of work of the minimum value of 40% of the estimated amount put to tender under the authority of State / Central Govt., State / Central Govt. undertaking / Statutory Bodies constituted under the statute of

- ii. Intending tenderers should produce credentials of 2 (two) similar nature of work, each of the minimum value of 30% of the estimated amount put to tender under the authority of State / Central Govt., State / Central Govt. undertaking / Statutory Bodies constituted under the statute of the Central / State Government during 5 (Five) years prior to the date of issue of the tender notice; or,
- iii. Intending tenderers should produce credentials of one single running work of similar nature of work which has been completed to the extent of 80% or more and value of which is not less than the desired value at (i) above;

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e., the tenderer.

N.B.: In case of 8. ix) [A i.] Work Order, Completion Certificate with Gross Bill Value or Payment Certificate for successful completed work shall have to be submitted but in case of 8. ix) [A ii.] the Certificate of satisfactory running work shall have to be submitted.

- 12. The tenderers shall have to show original copies of the submitted documents at the time of evaluation of the tenders.
- 13. Tenderer or his authorised representative must be present at the time of opening of "Part I (Technical Bid)" & "Part II (Financial Bid)".
- 14. <u>Details of Work</u>: The details of the work may be seen in the tender documents / papers or from the tendering wing of the Engineering Section.
- 15. The tendering authority is not bound to accept the lowest rates and reserves the right to cancel any or the entire tender / (s) without assigning any reason there to.

The same may be released after completion of the work with value of at least 80%.
