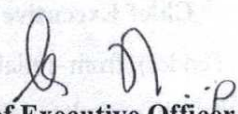

- i) No security deposit shall be refunded to the contractor for 1st 3 years from the actual date of completion of the work;
- ii) 30% of the security deposit shall be refunded to the contractor on expiry of **four years** from the actual date of completion of the work;
- i. The balance 70% of the security deposit shall be refunded to the contractor on expiry of **five years** from the actual date of completion of the work.

In the event of any of the above-mentioned dates being declared as a holiday for SJDA the tender will be opened on the next working day at the appointed time.

The documents submitted by the bidders should be properly indexed & attested with seal.

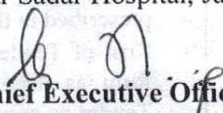
