EXPRESSION OF INTEREST FOR PREPARATION OF DPR COMPRISING OF DETAILED SURVEY, PLANNING, DESIGNING, ESTIMATE & PERIODICAL SUPERVISION DRAWING FOR CONSTRUCTION OF GATES WITH BEAUTIFICATION AT (1) ASSAM MORE AND (2) PAHARPUR MORE AND CONSTRUCTION OF CLOCK TOWER AT SAMAJPARA MORE, JALPAIGURI.

Sealed Expression of Interest (EOI) are invited by Siliguri Jalpaiguri Development Authority (SJDA) from the registered, bonafide, reliable and resourceful Architects / Agencies / Consultancy Firms having experience of not less than five years in Planning, Designing and preparation of DPR.

About the Project:

CONSTRUCTION OF GATES WITH BEAUTIFICATION AT (1) ASSAM MORE AND (2) PAHARPUR MORE AND CONSTRUCTION OF CLOCK TOWER AT SAMAJPARA MORE, JALPAIGURI.

The following components are to be provided within the project area.

- i. Path way with designer interlocking block along the both flanks of 30 m. stretches of the road on either side of the concerned Gates & Clock Tower .
- ii. Ornamental Peripheral boundary fencing.
- iii. Land scaping.

Scope of Work:

The work would include surveying preparation of detailed Architectural and RCC Drawings, including preparation of detailed estimate of the proposed project:

- 1) Architectural Designs including preparation of Plans, with detailed Drawings. Architectural Detailed Plan & Structural design & Soil exploration including periodical supervision as and when necessary.
- 2) Preparation of detailed estimate, for the works. The estimate is to be prepared on basis of latest PWD Schedule. For nonscheduled items, analysis of rates may also be provided in proper form with the invitation at least three quotations.

ELEGIBILITY TO PARTICIPATE:

Registered, bonafide, reliable and resourceful Architects / Agencies / Consultancy Firms having not less than **five years** of experience in designing similar type of work may participate in this Expression of Interest (EOI). The Multi-Disciplinary Firms / Agencies / Consultancy Firms, who have executed similar projects, may also submit their proposals. All of them should also have experience in planning and designing of at least one project of similar nature.

SELECTION / ACCEPTANCE OF THE SUCCESSFUL BID/ OFFER:

- a) The accepting authority/ SJDA reserves right to withdraw from whole process or any part thereof, accept or reject any or all bid(s)/offer(s) including the lowest bid/offer received at any stage of the process without assigning any reason whatsoever to the participants. No formal obligation shall accrue to SJDA or in such an event authority shall not be responsible for non- receipt of correspondence sent by post/e-mail/fax/courier.
- b) For selection/finalization of the offer/bid, at first responsiveness will be verified as per eligibility criteria and submitted documents.


Technical bid shall contain.

- 1) Trade License/Company Registration Certificate valid at least up to the date of submitting their bid.
 - 2) Income Tax (I.T.) PAN.
 - 3) Experience on successful preparation of similar type of works specifying eligibility criteria.
 - 4) Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017.
 - 5) "Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017" / in terms of 4374 F (Y),
- Any participant bidder not following the steps in submitting their bid /offer as described are liable to be disqualified.

TERMS & CONDITIONS:

1. Before submitting any bid offer, the intending participants should make themselves acquainted, thoroughly, with the local conditions prevailing by actual inspection of the site and take into considerations all aspects including actual size and availability of land, communication facilities, climate conditions etc. As no claim whatsoever will be entertained on these accounts, afterwards.
2. As per the evaluation criteria specified above, selected successful bidder maybe called for negotiations for improvement of Terms of Reference and scope of work and financial terms. SJDA reserves the right to negotiate with the successful bidder.
3. The selected bidder will have to enter into an agreement of contract with SJDA.
4. The detailed drawings would have to be submitted by the Architect / Agency / Consultancy Firm within 30 (Three Zero) days from the date of issue of LOI.
5. Any bid/offer containing overwriting is liable to be rejected. All corrections are to be attested under the dated signature of the bidder without which the bid/offer may be informal.
6. Last date & time of Submission: **09.08.2019 up to 4.30 PM.**
7. **Receiving of Tender Documents / Papers:** Tender will be received through tender box kept in the office of the Chief Executive Officer, Siliguri Jalpaiguri Development Authority, Siliguri.


