Undertakings / Autonomous Bodies / Statutory Bodies and Local Bodies is eligible for the under mentioned works.

Scope of Work:

- 1. Survey, planning, design and drawing of bio-remedial / phyto-remedial measures and construction of the structure for the same.
- 2. Planning and design to be done as per available necessary data at the downstream of the Drain connecting with river Mahananda within suitable distance
- Construction of the structure for implementation of bio-remedial / phyto-remedial activities along the drain.

- 4. Installation of necessary dozing equipments if necessary as per nature of the drain and operation and maintenance of the same for 1 (one) year.
- Any other methodology for treatment of drain water with a target to reduce BOD / COD and other parameters which causes pollution to river Mahananda.
- Note 1: Bidders are requested to submit their offer including a schematic drawing / planning with mentioning probable items of work and name of installation of equipments if required otherwise the bid will not be considered.
- Note 2: Bidders are also requested to consider the probable cost of conducting detailed survey to find out total number of outfalls / drains which are falling on the concerned drain including testing of sewage characteristic for the same.

Qualification requirements as listed briefly below are required to be fulfilled by the bidder. [Bidders are advised to refer to the bidding documents for complete details.]

Financial:

- a. The Bidder shall demonstrate that it possesses a turnover equivalent to minimum of INR 50.00 Lakh in each of the last three financial years preceding the date of submission of bid.
- b. The Bidder shall demonstrate by submitting along with its bid, a banker's certificate that it has available cash credit facility equivalent to minimum INR 50.00 Lakh as on the date of submission of bid.

Technical:

- The Bidder shall provide evidence that it has designed, developed, built any type of rain/ canal rejuvenation work / infrastructural work / waste water treatment work / Lifting / Pumping Station etc. for this contract during last 5 years preceding the month of publication of NIT.
- 2. Scanned copy of PAN Card, Professional Tax Clearance Certificate & Up-to-date Challan, Valid Income Tax Return (Last 3 years), GST Registration Certificate & Up-to-date Challan, Last 3 years Audited Balance Sheet, Credentials, Work Order, Payment certificate, Valid Provident Fund & Up-to-date Challan and ESI Registration Certificate & Up-to-date Challan and other supporting documents of the company must be submitted duly digitally signed at desired location in the website https://wbtenders.gov.in.
- 3. Scanned Copy of one affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution through on line at desired location.

Bidders are advised to obtain the hard copy of the bidding document for preparation of their bids.

After opening of Tender only L1 bidder shall submit the hard copy of the original Bid Security and other documents (in original) to the Tender Inviting Authority with his acceptance of letter of the LOI. Failure to submit the hard copy with acceptance letter within the time period prescribe for the purpose, may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including blacklisting of the bidder.

The intending Tenderers are required to quote the rate online.

During scrutiny, if it comes to the notice of the Tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the Tender and that application will be rejected without any prejudice.

The CEO, SJDA reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

Before issuance of the WORK ORDER, the Tender inviting authority may verify the credential and other documents of the lowest Tenderer if found necessary. After verification if it is found that the documents submitted by the lowest Tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.
