
As per Notification No. 5784-PW/L&A/2M-175/2017, Dated: 12.09.2017 For work with five years Defect Liability Period:

- i) No security deposit shall be refunded to the contractor for 1st 3 years from the actual date of completion of the work;
 - ii) 30% of the security deposit shall be refunded to the contractor on expiry of four years from the actual date of completion of the work;
- The balance 70% of the security deposit shall be refunded to the contractor on expiry of five years from the actual date of completion of the work.




