3. Siliguri Jalpaiguri Development Authority (SJDA) shall provide No Objection Certificate to the Tenant for obtaining electric and water connection for their use.
4. That the said premises during tenancy period shall also maintained in good and perfect condition by the tenant.
5. That the Tenant may also provide own Security Guard for their Tenancy area
6. The tenant shall not be allowed to sub-let or assign the said rented premises or any portion thereof to anybody nor he shall be permitted the same or any portion thereof to be occupied by any other person/persons without the written consent of the SJDA.
7. That the tenant shall not be allowed or entitled to make any additions to the below scheduled property which involves structural changes without written consent of the SJDA But the Tenant shall however, be entitled to erect wooden and other light weight partition, cabin and air conditioners may be allowed without hampering the main structure and to make alteration in additions to light paints, wiring, plumbing and sanitary fixtures with the consent of the SJDA.
8. That the tenant shall remove at his own cost day by day and every day all refusals, ashes, offal and dirt of every kind and keep the said premises clean and hygienic condition at their cost.
9. That the tenant shall not create any nuisance/ disturbance to any other names / tenant within the complex.
