- 15. Tenderer or his authorized representative must be present at the time of opening of "Part I (Technical Bid)" & "Part II (Financial Bid)".

- 17. The tendering authority is not bound to accept the lowest rates and reserves the right to cancel any or the entire tender / (s) without assigning any reason there to.
