Terms and condition:-

1. Earnest Money to be deposited only by A/C payee DD or Banker Cheques in favour of Chief Executive Officer, SJDA.
2. The successful quotationers for have to deposit the full amount of the accepted rate in 1 (one) instalment in advance within 7 (seven) days from the date of receipt of offer letter through A/C payee demand draft or Banker Cheque in favour of Chief Executive Officer, SJDA.
3. Earnest money will be refunded to unsuccessful bidder.
4. Earnest money will be returned to successful bidder on deposition of accepted price within due time, failing which the same will be forfeited.
5. On being selected, if the concerned agency fails to respond within the stipulated time as per its quoted rate, then the agency will not be allowed to participate in similar tenders in future.

7. The Agency shall not make any addition/alteration or construct any structure at the Parking Lot.
