Chief Executive Officer, Siliguri Jalpaiguri Development Authority (SJDA), Siliguri invites ONLINE TENDER (e - Tender) from reliable resourceful bonafide Manufacture / Distributor / Stockiest and individual contractor who have satisfactorily completed as a prime agency during the last 5(five) years prior to the date of issue of this Notice a single and similar nature of work of SJDA or of State/Central Govt. Deptt or statutory body, Zilla Parishad, Mahukuma Parishad, Panchayat Samiti or Municipality having value of Rs. 15.00 (Fifteen) Lac only in a single order.

<u>Name of Work:</u> Providing Street Lighting from Uttarkanya to Jorapani Bridge approach near Doordarshan Kendra, Fulbari, Dist. Jalpaiguri. (SH. Supply of LED Fittings.)

- 1. **E- Filing:** In the event of e-Filing intending bidder has to download the bid document from the website http://etender.wb.nic.in directly with the help of Digital Signature Certificate. (Details of which has been narrated in "Instruction to Bidders")
- 2. Earnest Money amounting to ₹. 40,000/-(Forty thousand) only to be deposited in the form of NEFT / RTGS / DD from any CBS enabled Bank and acknowledgement should also be uploaded online with UTR No. [Account Details: i) Account Name SILIGURI JALPAIGURI DEVELOPMENT AUTHORITY, ii) Account No. 912010035059401, iii) Bank Name AXIS BANK LTD., iv) Branch Name Hill Cart Road, v) IFSC UTIB0001403 & vi) Bank Address 32, Pradhan Nagar, Near Ramakrishna Vedanta Ashram, Hill Cart Road, Siliguri 734 003] (to be converted into Performance Guarantee on selection).along with application in letter headed pad before technical bid opening. Any bidding without earnest money shall be treated as informal and shall automatically stand cancelled. (No Exemption of Earnest Money will be allowed for Regd. Cooperative Society). Technical Bid (Credential) & Financial bid (Rate) both will be submitted concurrently duly digitally signed in the Website http://etender.wb.nic.in. Tender document may be downloaded from website & submission of Technical Bid/Financial Bid to be made as per Bidding Schedule. The documents submitted by the bidder should be properly indexed.
- 3. Eligibility criteria for participation in tender:
  - a. The prospective bidder shall have satisfactorily completed as a prime agency during the last 5(five) years prior to the date of issue of this Notice a single and similar nature of work of SJDA or of State/Central Govt. Deptt or statutory body, Zilla Parishad, Mahukuma Parishad, Panchayat Samiti or Municipality having value of ₹. 15.00 (Fifteen) lakhs).
  - b. Pan Card, Income Tax acknowledgement receipt for Assessment year 2013-14 or 2014-15,
  - c. Registered Unemployed Engineers' Co-operative Societies/ Unemployed Labour Co.- Op. Societies are required to submit as follows
    - i. Valid Registration certificate issued by the Co-operative Deptt.
    - ii. Audit report audited by Co-operative Deptt. for the year 2014-15.
    - iii. Resolution copy of Annual General meeting for the year 2014-15.
  - d. The partnership firm shall furnish the registered partnership deed.
- 4. Vat, Royalty & all other statutory levy/ Cess if applicable will have to be borne by the agency.
- 5. A written declaration in the form of affidavit before notary as the correctness of copies of all documents mentioning the NIT No. & Name of Work.

- 6. Agency need to enter in an agreement with SJDA after selection.
- 7. Defaulter agencies w.r.t. any works awarded earlier by SJDA will not be considered for the works.
- 8. The intending bidder shall clearly understand that whatever may be the outcome of the present invitation of bid, the Chief Executive Officer, Siliguri Jalpaiguri Development Authority reserves the right to reject any application for participating in the bid and to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any bidder at the stage of bid.
- 9. No CONDITIONAL/ INCOMPLETE bid will be accepted under any circumstances.
- 10. During scrutiny, if it is come to the notice to bid inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
- 11. Before issuance of the work order, the bid inviting authority may verify the credential & other documents of the lowest bidder if found necessary. After verification, if it is found that such documents submitted by the lowest bidder is either manufactured or false in that case, work order will not be issued in favour of the tenderer under any circumstances.
- 12. The engagement may be cancelled any time without compensation in the event of Natural calamities, War, Govt. Direction etc. or for any such events beyond the control the Authority, or where the agencies entrusted / engaged in illegal/unlawful activity in the said location/premises.
- 13. Qualification Criteria: The tenderer shall have to meet all the minimum criteria regarding:
  - a. Financial Capacity
  - b. Experience / Credential

The eligibility of a tenderer will be ascertained on the basis of uploaded documents in support of the minimum criteria as mentioned in a & b above.

- 14. **Refund of EMD:** The Earnest Money of all the unsuccessful Tenderer will be refunded
- 15. The tenderer shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970(b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
- 16. The Successful bidder will also has to sign an agreement with the Chief Executive Officer, Siliguri Jalpaiguri Development Authority on requisite stamp. The bid documents along with other Terms and Conditions shall form part of the agreement and the Successful bidder shall be bound himself / themselves to bid by the same. The undersigned shall also reserve the right either to accept or reject any or all the bidders without assigning any reason whatsoever.
- 17. Apart from Manufacturer, Authorization Certificate is required for bid submission from Luminaire Manufacturer to be submitted in the technical bid.
- 18. One bidder can quote one luminaire manufacturer only.
- 19. The bidder should submit the technical brochure of the LED Luminaire Offered.

#### Scope of Work with Terms and Conditions: -

- 1) The Supply has to be completed within 10 (Ten) Days from the date of issue of Work Order.
- 2) The rates quoted must be inclusive of 7 (Seven) years free of cost maintenance of LED sets including all applicable taxes,levies,State Sales Tax, VAT, other related taxes and freight charges up to Siliguri.
- 3) The Supply works shall be carried out by the "Supplier/Contractor" strictly as per the technical specifications mentioned in the Schedule & Additional Specification of the tender documents.
- 4) The Supplier/Contractor shall supply all LED street light sets covering all risks during transit, loading, unloading and shall indemnify the Purchaser i.e. the Siliguri Jalpaiguri Development Authority.
- 5) All guarantee / warranty papers have to be in favour of the C.E.O, SJDA and must be handed over to the Authority so that in case of any disorder within the warranty period the products shall be replaced. The Supplier has to provide service till the end of the warranty period without any additional payment.
- 6) The Supplier must have an establishment in the local area to meet up the complaint. The detail address with phone No. and Mail ID to be furnished in their letter head during participation.
- 7) In case of additional requirement, the authority may place an order for additional quantity at quoted rate and the Supplier/Contractor has to execute the order without claiming any extra cost and condition.

#### 1. Terms of Payment:

- a) Guarantee, Warranty and Maintenance of product after supply of works: Guarantee, Warranty and Maintenance of LED Light sets are of prime importance for this supply work. Continuous 7 (seven) years free of cost of maintenance with replacement of requisite spare parts will be provided by the Supplier/Contractor. No lame excuse such as electricity fault / earth fault etc. for the cause of damage of the LED set will any way be entertained. The maintenance work should be carried out within 3(three) days from the date of complaint about the defect of LED light set, failing which, after expiry of 3 (three) days, penalty @0.1% (zero point one percent) per day, on accepted rate of each LED light set will be levied and the requisite levy amount will be deducted from the Security Deposit amount of 10% (ten per cent). The amount of EMD of the successful supplier/contractor will be adjusted with 10% Security Deposit amount.
- b) Security Deposit amount of 10% (ten percent) of supply order value will be released on receipt of Bank Guarantee and the Bank Guarantee will duly be released after completion of satisfactory free of cost maintenance of Luminaire period of 7 (seven) years.
- 2. The Supplier/Contractor undertakes to complete the work within 10 days from the date of receipt of the Supply order. If there is any delay for any act or legislation or restriction or prohibition or restrain imposed by any statutory body and/or Government Authority, or for any other reason beyond the control of the Supplier/Contractor and the Purchaser, no liability whatsoever shall be imposed upon the Supplier/Contractor as well as upon the Purchaser

<u>Documents to be submitted</u>: Self attested Copies of the following documents will be submitted by the bidder /(s) for pre-qualification. Failure of submission of any of the documents as listed below will render the bidder liable to be summarily rejected.

- i) Trade License.
- ii) Income Tax (I.T.) PAN.
- iii) Updated challan of Sales tax.
- iv) **VAT** Registration Certificate.

- v) List of similar nature of supply of LED Fittings amounting to Rs. 15.00 Lakhs in a single job, executed by the supplier during last 5 years in any Govt./ Semi Govt. Deptt./PSU/ Local Bodies along with **Work Order & Completion certificate**.
- vi) A written declaration in the form of **Affidavit before Notary** as the correctness of the copies of all documents mentioning the NIT no and name of the work.
- 1. The bidder shall have to show original copies of the submitted documents at the time of evaluation of the bids.
- 2. The bidder or their authorized representatives may like to be present at the time of opening. The schedule of opening may be altered depending on unavoidable circumstances.
- 3. Bidder shall not be in a conflict of interest with one or more parties in the bidding process.
- 4. SJDA reserves right to withdraw from whole process or any part thereof to accept or reject any or all offer at any stage of the process. No formal obligation shall accrue to SJDA or in such an event authority shall not be responsible for non-receipt of correspondence sent by post / e-mail / fax / courier.
- 5. The lowest bidder will have to enter into an agreement in SJDA's format within **7** (**Seven**) **working Days** else the same will be treated as cancelled.

## **Technical Specification LED Street Light**

- 1. The IP classification of the whole luminaire should not be less than IP65/IP66. Certificate from NABL certified Lab in technical bid documents is must.
- 2. LED street light Luminaire should be having single piece pressure die cast aluminium housing with supplier word mark / name engraved / embossing on the die cast housing to allow traceability till life of fixture ( Sticker / Printing is not acceptable )
- 3. LM79 report should be produced from Govt. approved / NABL certified Lab at the time submission of technical bid documents.
- 4. Design should be such that glare is minimum and fully comply to Cut Off category of light distribution as per Indian standard IS1944 (Part I and II).
- 5. Luminaire housing and luminaire driver should be from the same manufacture.
- 6. A sample luminaire to be got it approved by the Engineer-In-Charge before supply of full quantity.
