Chief Executive Officer, Siliguri Jalpaiguri Development Authority (SJDA), Siliguri invites ONLINE Bidding of the following works.

#### Name of Work: Maintenance of Trident Light Poles located within the SMC area of Siliguri.

- 1. **Tenure:** The tenure for maintenance will be initially for 1 (One) year but may be extended for another two years on satisfactory performance. But the agency has to quote rate for 1 (one) year only and the same rate will be applicable for consecutive years.
- 2. **E-Filing:** In the event of e-Filing intending bidder has to download the bid document from the website http://etender.wb.nic.in directly with the help of Digital Signature Certificate. (Details of which has been narrated in **"Instruction to Bidders"**)
- 3. Earnest Money amounting to ₹. 50,000/-(Fifty thousand) only to be deposited in the form of Demand Draft (DD) NEFT / RTGS from any CBS enabled Bank and acknowledgement should also be uploaded online with UTR No. [Account Details: i) Account Name – SILIGURI – JALPAIGURI DEVELOPMENT AUTHORITY, ii) Account No. – 912010035059401, iii) Bank Name – AXIS BANK LTD., iv) Branch Name – Hill Cart Road, v) IFSC – UTIB0001403 & vi) Bank Address – 32, Pradhan Nagar, Near Ramakrishna Vedanta Ashram, Hill Cart Road, Siliguri – 734 003] (to be converted into Performance Guarantee on selection).along with application in letter headed pad before technical bid opening.. Any bidding without earnest money shall be treated as informal and shall automatically stand cancelled. (No Exemption of Earnest Money will be allowed for Regd. Cooperative Society). Technical Bid (Credential) & Financial bid (Rate) both will be submitted concurrently duly digitally signed in the Website http://etender.wb.nic.in. Tender document may be downloaded from website & submission of Technical Bid/Financial Bid to be made as per Bidding Schedule stated in serial no-7. The documents submitted by the bidder should be properly indexed.

#### 4. Eligibility criteria for participation in tender:

- a. The prospective bidder shall have satisfactorily completed as a prime agency during the last 5(five) years prior to the date of issue of this Notice a single and similar nature of work of SJDA or of State/Central Govt. Deptt or statutory body, Zilla Parishad, Mahukuma Parishad, Panchayat Samiti or Municipality having value of ₹. 3.00 (three) lakhs).
- b. Pan Card, Income Tax acknowledgement receipt for Assessment year 2013-14 or 2014-15,
- c. Professional Tax receipts Challan for the year 2013-2014 or 2014-15 to be accompanied with the Technical bid document.
- d. Registered Unemployed Engineers' Co-operative Societies/ Unemployed Labour Co.- Op. Societies are required to submit as follows
  - i. Valid Registration certificate issued by the Co-operative Deptt.

- ii. Audit report audited by Co-operative Deptt. for the year 2014-15.
- iii. Resolution copy of Annual General meeting for the year 2014-15.
- e. The partnership firm shall furnish the registered partnership deed.
- f. Valid Electrical Contractors License.
- g. Supervisors Certificate of Part-1, 2, 4, 6A, 6B, 7A, 7B & 10.
- 5. Vat, Royalty & all other statutory levy/ Cess if applicable will have to be borne by the agency.
- 6. A written declaration in the form of affidavit before notary as the correctness of copies of all documents mentioning the NIT No. & Name of Work.

#### Date & Time Schedule:

- 7. The Agency shall not make any addition or alternation of the existing structure in any manner whatsoever without permission of Engineer in Charge.
- 8. Agency need to enter in an agreement with SJDA after selection.
- 9. Defaulter agencies w.r.t. any works awarded earlier by SJDA will not be considered for the works.
- 10. The intending bidder shall clearly understand that whatever may be the outcome of the present invitation of bid, the Chief Executive Officer, Siliguri Jalpaiguri Development Authority reserves the right to reject any application for participating in the bid and to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any bidder at the stage of bid.
- 11. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' before bidding
- 12. No CONDITIONAL/ INCOMPLETE bid will be accepted under any circumstances.
- 13. In case of Quoting rate, no multiple rate will be entertained by the SJDA.
- 14. During scrutiny, if it is come to the notice to bid inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
- 15. Before issuance of the work order, the bid inviting authority may verify the credential & other documents of the lowest bidder if found necessary. After verification, if it is found that such documents submitted by the lowest bidder is either manufactured or false in that case, work order will not be issued in favour of the tenderer under any circumstances.
- 16. The engagement may be cancelled any time without compensation in the event of Natural calamities, War, Govt. Direction etc. or for any such events beyond the control the Authority, or where the agencies entrusted / engaged in illegal/unlawful activity in the said location/premises.
- 17. Qualification Criteria: The tenderer shall have to meet all the minimum criteria regarding:
  - a. Financial Capacity
  - b. Experience / Credential

The eligibility of a tenderer will be ascertained on the basis of uploaded documents in support of the minimum criteria as mentioned in a & b above.

18. **Refund of EMD:** The Earnest Money of all the unsuccessful Tenderer will be refunded

- 19. The tenderer shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970(b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
- 20. The Successful bidder will also has to sign an agreement with the Chief Executive Officer, Siliguri Jalpaiguri Development Authority on requisite stamp. The bid documents along with other Terms and Conditions shall form part of the agreement and the Successful bidder shall be bound himself / themselves to bid by the same. The undersigned shall also reserve the right either to accept or reject any or all the bidders without assigning any reason whatsoever.

## Scope of Work with Terms and Conditions: -

- a) The Street Light Poles will be handed over such as they are.
- b) On the date of handing over the site, nos. of glowing/ non- glowing status and status of other apparatus such as feeder pillars, loop boxes, timer switch etc. are to be noted and to be signed jointly by the agency and AE (Elect) and countersigned by SE.
- c) After handover the Agency will have to check, repair or replace or rectify (as required) the Poles and all the related parts and its fittings, O.H/ U.G line/cable and CFL/ Vapour/ Metal /LED lamps, also have to keep the poles straight in position with cement concrete (1:2:4), plaster (6:1) etc. all complete, so that the pole lights keep on glowing. Skilled electricians/wiremen who are having requisite certificate from the Director of Electricity will have to be engaged and must ensure about the necessary safety measures. SJDA will not be responsible for any accident of the staff/worker(s) engaged by the Agency. In any case if happened, Authority will not provide any compensation for any such accident.
- d) The status of each site will be reviewed by the authority once in fifteen days.
- e) Any damage due to natural calamity or others to be informed to the authority within 24 hrs and necessary inspection to be made by the authority in next 24 hrs.
- f) Routine inspection should have to be made during peak-hours i.e. (in the Evening) in each and every day.
- g) Agency must have to ensure that all the poles and its lights are lighted up and put off in time by setting of Timer switch or manually if not available).
- h) If lights found or reported glowing before or after the setting time or not glowing after the setting time, a sum of ₹. 50 for each light per day will be deducted from the quoted rate/ Performance Guarantee deposit without making any further communication.
- i) If any light of his jurisdiction is seen or reported not glowing for consecutive 2 (two) days or found broken, a sum of ₹. 50.00 for each light per day from the third day onwards will be deducted from the quoted rate/ Performance Guarantee deposit without making any further communication.
- j) If it is found that more than 15% of each stretch, may be in a scattered location, not glowing/ broken, an amount of ₹. 1000.00 (one thousand) from day 1 (one) will be deducted from the quoted rate/ Performance Guarantee deposit additionally along with existing penalty charges as on (h) and (i).
- k) The Agency shall be responsible for keeping up to date the distribution box, feeder pillar box/ panel Board, service connection, meter box unit, timer machine and switch, loop box etc.
- 1) All tools and plants, ladder, electrical apparatus, use of any vehicles if required etc. will have to be arranged and all costs will have to be borne by the Agency.
- m) All the poles with light fittings including lamps and other related parts to be handed over to the Authority in good and functional condition /position before the end of the contract period. A joint verification will be done before the expiry of the contract on any day but within 15 (fifteen) working days. All dues will be released only after a satisfactory report of the visit, otherwise penal charge will be implemented as per contract conditions.
- n) For any repairing work, if lights have to be put on daytime, concern Assistant Engineer must be informed in advance over telephone or via SMS.
- o) On selection, Performance Guarantee of ₹. 1,00,000/- (One Lakh) have to be deposited in favour of SJDA at the time of Formal Agreement within 7 (Seven) working Days.
- p) If instructed to maintain any new area / stretch or withheld any stretch or part, addition or subtraction of maintenance cost will be done proportionately from the appropriate yearly quoted amount. Calculation will be done based on the maintenance cost per Light Fittings per day multiplied by number of remaining days of the year. All the terms and conditions will remain be same.

- q) The Bill will have to be submitted quarterly and payment will be made after certification of the authorised Officer and after deducting the penalty charges (if any) and necessary taxes etc. as per Govt. norms.
- r) The successful bidder will have to execute an agreement with other formalities or improper / insufficient maintenance, the authority will reduce the rate as deemed fit in conformity to the clauses of basic agreement. However, for disruption of electric supply due to fault of WBSEDCL or natural calamity the Agency will not be held responsible.
- s) All works shall be executed in adherence to the Electricity Act, 2003.
- t) Bidder shall not be in a conflict of interest with one or more parties in the bidding process.
- u) SJDA reserves right to withdraw from whole process or any part thereof to accept or reject any or all offer at any stage of the process. No formal obligation shall accrue to SJDA or in such an event authority shall not be responsible for non-receipt of correspondence sent by post / e-mail / fax / courier.
