2. Base Rate: Rs. 2,25,000/- + Government Taxes. Rate quoted should not be below the base rate. Rate quoted below the base rate will be rejected.

3A. Period of Work: 1 (One) year from the date of taking over the possession which may be extended for another 2 (two) year on satisfactory execution of the work and timely deposition of upfront money yearly with increment of 5% every year.

3B. Quoting of Rate: All intending bidders should offer the rate on yearly basis (excluding Govt. taxes as applicable).

4. Earnest Money amounting to Rs.10,000/- (Ten Thousand only) to be submitted online in favour of the Chief Executive Officer, Siliguri Jalpaiguri Development Authority (To be converted into Security Deposit on selection of successful bidder). At the time of uploading the E-Bid, the intending bidder should select the Bid and initiate payment of pre-defined EMD for that Bid by selecting from either of the following payment modes:

SPECIAL TERMS AND CONDITIONS

1. The Kiosks size should be not above 04 ft x 03 ft in each pole.
2. The site of installing advertisement is 172 Nos. of LED Street light Poles located at the site near Salbari Bazar from DPS to Siliguri Institute of Technology (SIT).
3. The agency shall not make any addition or alternation of the structures.
4. The agency should take care that no damage to the property is caused from the part of the agency or his employee and the agency shall be responsible to reimburse/compensate for any such damage.
5. The agency shall not exhibit such Ad. Matter which are obscene in character and test and may disturb public peace and tranquillity. No matter relating to items that may cause health hazard like tobacco products or liquor etc. shall be advertised.
6. The agency may be allowed to display Ad matters initially for a period of 1 (one) year, it may be extended for another Two years, subject to minimum increase 5% rate every year. On satisfactory performance and timely payment of upfront money.

INSTRUCTION TO BIDDERS

SECTION - A

1. General guidance for e-Bidding

Instruction / Guidelines for bidders for electronic submission of the bid online have been annexed for assisting the agencies to participate in e-Tendering.

2. Registration of Bidder

Any bidder willing to take part in the process of e-bidding will have to be enrolled & registered with the Government e-Procurement system, through logging on to <https://etender.wb.nic.in>. The agency is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC)

Each bidder is required to obtain a class - III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2 of Guideline to tendered DSC is given us a USB e-Token. Where an individual person holds a digital certificate in his own name duly issued to him against the company of the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender / bidder for and on behalf of such company or firm invariable upload a copy or registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partner of such firm, to upload such bidder.
