Chief Executive Officer, Siliguri Jalpaiguri Development Authority (SJDA), Siliguri invites Item rate ONLINE Bidding of the following works.

Name of Work: Proposal for obtaining new entity under NETC FASTag at Paribahan Nagar Truck Terminus at Matigara.

Earnest Money: The amount of Earnest Money Rs. 20,000.00(Twenty Thousand) Only is to be submitted online in favour of the Chief Executive Officer, Siliguri Jalpaiguri Development Authority (SJDA) At the time of uploading the tender / quotation, the intending tenderer,/ quotationer should select the tender to bid and initiate payment of pre-defined EMD for that tender by selecting from either of the following payment modes:

- i) Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank Payment Gateway.
- ii) RTGS/NEFT in case of offline payment through bank account in any Bank with his / her tender / quotation as per Memorandum No. 3975-F(Y) dated: 28.07.2016 of Secretary to the Government of West Bengal, Finance Department. The L1 bidder shall make the Formal Agreement after 'getting the Letter of Acceptance (LOA) issued by the Tender Inviting Authority. - 6. Defaulter agencies w.r.t. any works awarded earlier by SJDA will not be considered for the works.
- 7. The intending bidder shall clearly understand that whatever may be the outcome of the present invitation of bid, the Chief Executive Officer, Siliguri Jalpaiguri Development Authority reserves the right to reject any application for participating in the bid and to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any bidder at the stage of bid.
- 8. No CONDITIONAL/ INCOMPLETE bid will be accepted under any circumstances.
- During scrutiny, if it is come to the notice to bid inviting authority that the credential or any other papers
 found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the tender and that
 application will be out rightly rejected without any prejudice.
- 10. Before issuance of the work order, the bid inviting authority may verify the credential & other documents of the lowest bidder if found necessary. After verification, if it is found that such documents submitted by the lowest bidder is either manufactured or false in that case, work order will not be issued in favour of the tenderer under any circumstances.
- 11. The engagement may be cancelled any time without compensation in the event of Natural calamities, War, Govt. Direction etc. or for any such events beyond the control the Authority, or where the agencies entrusted / engaged in illegal/unlawful activity in the said location/premises.
- 12. Qualification Criteria: The tenderer shall have to meet all the minimum criteria regarding:
 - a. Financial Capacity
 - b. Experience / Credential

The eligibility of a tenderer will be ascertained on the basis of uploaded documents in support of the minimum criteria as mentioned in a & b above.

- 13. Refund of EMD: The Earnest Money of all the unsuccessful Tenderer will be refunded.
- 14. The tenderer shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970(b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
- 15. The Successful bidder will also has to sign an agreement with the Chief Executive Officer, Siliguri Jalpaiguri Development Authority on requisite stamp. The bid documents along with other Terms and Conditions shall form part of the agreement and the Successful bidder shall be bound himself / themselves to bid by the same. The undersigned shall also reserve the right either to accept or reject any or all the bidders without assigning any reason whatsoever.
- 16. The Quoted rate must be including GST, LWC & Other Govt. Statutory taxes. No further claim will be entertained.
- SPECIAL consideration: MSME and STARTUP India registered organizations shall be exempted from Number of years of experience and Turnover requirement. Tender fee shall be paid

Scope of Work

The system integrator will have to survey the site before preparing proposal.

Smart parking system should have the following features. Automatic FASTag reader with dual validation of vehicle details through ANPR – Automatic Number Plate recognition. At the time of Entry of vehicle FASTag should be scanned, number plate recognized through ANPR and automatic entry ticket with timestamp and image to be captured.

At the time of Exit, same process to be repeated and basis the government issued tariff, the parking fee is calculated and deducted automatically through FASTag. In case the Truck/Bus/Car does not have FASTag or no funds in FASTag, a dynamic QR Code should generate on the POS machine to enable digital payment. In case driver is unable to pay through FASTag or QR Code, cash option should be provided. Display should show fee charged, vehicle number and mode of payment.

Following additional features are also required -

1. Vehicle Counter - Artificial Intelligence enabled cameras to capture Entry and Exit of all vehicles. This data

- should match with the Entry and Exit count of vehicles though payment gates
- 2. Site Pass for regular visitors, monthly pass system should be possible. Identification of pass holder vehicle to be performed through FASTag reader or ANPR. No additional sale of RFID tag will be allowed.
- 3. Dashboard & report system should be able to generate shift report, day collection, weekly and monthly reports. In case SJDA management require additional reports, the same should be generated without any additional charge of customization.
- 4. Upgrade and updation all upgrades and updation of system should be non-intrusive, if however downtime is required maximum 30 minutes is allowed.
- 5. Offline functioning in case there is power and internet outage, the system should work offline and upload data when system goes live later
- 6. Exempted vehicle no charges should be levied on Exempted vehicles such as ambulance, police van, fire department, other government department vehicle with permission to enter without charge
- Manual barrier operation in case the staff are operating barrier manually for any reason, the incident should be captured through lane cameras and incident recorded in the dashboard for later analysis.
- 8. On-Site resource to assist the SHG members in proper operation of high tech smart parking system, bidder has to provide a local resource to maintain system uptime, training and trouble shooting.
- 9. Data Backup images of the vehicle must be stored for 3 months and logs of vehicle movement for 3 years
- 10. Period of Completion: 30 Days from the issuance of Work Order.
