
NOTICE INVITING QUOTATION NIQ NO. - 001 / Engg / 2014 - 15 of SJDA

Name of work: Carriage of Packed Bitumen, maximum quantity is upto 1200 MT (net Weight) or the time period till 31st March'2015 whichever attains earlier, from Raninagar CFA to SJDA godown at Bagrakote, Siliguri.

- 1) The quotationers should quote their rates both in figure and in words on Rate per M.T. basis in sealed envelope subscribing name of the firm, subject matter and communication address & Contact No.
- 2) The quotationers are requested to submit their rates along with the credentials of carriage and PAN, VAT and up to date P.Tax challan along with Earnest Money of Rs. 10, 000.00 (Rs. One thousand) only as Bank Draft in favour of Chief Executive Officer, SJDA, Siliguri. Without Earnest Money the quotation will be treated as cancelled.
- 3) Supporting papers related with credentials as Carriage Order and Payment Certificate from Central / State Govt. / Govt. Undertakings & Enterprises / Local & semi-Govt. organizations and Development Authorities / Statutory Bodies for any type of Carriage in a single Carriage Order completed within last 3 (three) years.
- 4) Quoted rate should be given per M.T. and clearly mention that the rate should be Bitumen with Container. The quoted rate should be including carriage, loading, un-loading, stacking and all other incidental charges. No extra charges in any form will be admissible.


